Demolition or Moving of Buildings

Permit Application

A permit application form must be fully completed and signed by the registered owner of the land or his/her agent authorized in writing. The application must be accompanied by the required permit fee and plans.

Disconnection of Services

When demolishing or moving a building a Utility Clearances for Demolition Permit form must be completed and signed by the owner/applicant prior to the issuance of a demolition permit. (Page 6)

Moving of Buildings

The Highway Traffic Act provides that the municipality, having jurisdiction over highways to be occupied, may issue a moving permit. This permit must be obtained from authorities having jurisdiction over all roads to be used for the move. Where the building is to be moved to another property within the Township of Uxbridge limits, a separate building permit for foundations on the new location must be obtained prior to the issuance of a moving permit.

Heritage Uxbridge

Where applicable, notice to Heritage Uxbridge must be signed off by its official prior to the issuance of a demolition permit if the building/structure is on the Heritage Uxbridge's inventory.

Permit Fee

Initial permit fee shall be calculated in accordance with Schedule B of Building [By-law No. 2015-127](#). Personal cheques payable to the Township of Uxbridge, cash and/or debit are acceptable for payment of permit fee.

Other Fee

Where applicable, the following fee must be collected prior to the issuance of a building/demolition permit:

- Road Restoration Fee and Deposit

Demolishing Partial Building

Where applicable, the following certificates, reports and/or plans prepared by a professional engineer or architect shall be provided prior to the issuance of a demolition permit:

- Structural adequacy of the remaining building including proposed work required
- Fire safety systems of the remaining building including proposed work required

Advisory: It is the responsibility of the applicant to obtain the required approvals from the following appropriate authorities prior to moving of buildings and/or installing hoarding.

IMPORTANT NOTES

- The [Ontario Building Code](#) requires that a *Professional Engineer* be retained to review the demolition of any building with characteristics listed under items 4-7 in the above-noted chart.
- The tanks, pipelines and/or equipment that contain fuel must be removed from the site in accordance with the regulations and guidelines of the [Technical Standards and Safety Authority](#), Durham District, T.S.S.A. at 1-905-655-8396. Further environmental site assessment reports will be required when applying for future development.
- The [Occupational Health and Safety Act](#) and Regulations prescribe procedures for demolition involving hazardous materials such as asbestos and lead paint. It is the responsibility of the owner/authorized agent to ensure the safety of workers.
- All building/demolition sites must be maintained in a safe, tidy condition. A Building Inspector may visit your site to verify these conditions.

2012 Ontario Building Code Requirements.

Div. C. Article 1.2.2.3. The applicant for a permit respecting the demolition of a building shall retain a professional engineer to undertake the general review of the project during demolition, where:

- a) The building exceeds three (3) storeys in building height or 600m² (6460 ft²) in building area.
- b) The building structure includes pre-tensioned or post-tensioned members.
- c) It is proposed that the demolition will extend below the level of the footings of any adjacent building and occur within the angle of repose of the soil, drawn from the bottom of such footings, or
- d) Explosives or lasers are to be used during the course of demolition.

Div. B. Part. 8 “Safety Measures at Construction and Demolition Sites” of the 2010 National Building Code including CSA S350-M “Code of Practice for Safety in Demolition of Structures.”

OCCUPATIONAL HEALTH AND SAFETY ACT AND REGULATIONS (OHSAR)

In accordance with OSHAR, it is the responsibility of the building owner to ensure the safety of workers from hazardous materials. A detailed survey to determine the types and conditions of hazardous materials shall be carried out and provided to the Contractor prior to demolition.
