“Envisioning Our Uxbridge”

Have Your Say! The Township of Uxbridge is holding a Special Council Meeting to initiate a review of its Official Plan. This is the beginning of a project, “Envisioning Our Uxbridge”, that will shape and consolidate the former Regional Official Plan and the Township Official Plan into a single document. The approach to the Township Official Plan review will update the vision and planning framework in the official plan to ensure the achievement of the best quality of life for the community, both socially and economically, while accommodating the anticipated growth in the Township.

Why Review the Official Plan? The *Planning Act* requires the Township to, not less frequently than every five years for a plan which is not a new official plan, revise the official plan to ensure that it:

- conforms to provincial plans or does not conflict them;
- has regard to matters of provincial interest listed in Section 2 of the Planning Act; and,
- is consistent with policy statements issued under Section 3(1) of the Planning Act.

Why is there a Special Council Meeting? Before revising the Official Plan, Council is required by Section 26(3) of the *Planning Act* to hold a special meeting, open to the public, to discuss the revisions that may be required. The purpose of this meeting is to provide an opportunity for input into matters which members of the public believe should be considered as part of the Official Plan review. The meeting will consist of a presentation from the Township’s Planning Consultant and an opportunity to provide comments. This Special Council Meeting will be held on:

Any person may participate in the public meeting and/or make written or oral representation with respect to the Official Plan review. Any written submission, either in hard copy or in electronic format, must be forwarded to the Clerk’s department for receipt by noon on Friday, October 3, 2025, to be added to the meeting agenda. Please include your full name, address and telephone number. If you wish to make a formal oral submission, please contact the Clerk’s office by noon on Friday, October 3, 2025, to confirm your participation and receive the online call-in information before the meeting. Technical assistance may be provided to ensure you are able to participate.

If you wish to be notified of the decision of the Township of Uxbridge on any changes to the official plan resulting from the Official Plan review, you must make a written request to the Township Clerk at the Clerk's department or at dleroux@uxbridge.ca in order to be added to the interested party list.
