
Update – No Changes Feb. 18, 2020 Miller Boyington Pit # 3 Site Plan Development Application

This application requests site plan approval under the Planning Act for the rehabilitation and future use of a portion of the Miller Boyington Pit # 3 lands located at 4419 Conc. 7, Uxbridge On. Council gave approval to the project in principle in October 2015 and the applicant submitted the formal application in 2017. The applicant, as part of the site plan, is proposing a structure to store construction vehicles, equipment and signs. The applicant is also proposing importation of fill into a portion of the existing gravel pit at the site as part of the rehabilitation of this area of the pit. If the site plan application is approved, the current licence through MNR for this portion of the pit would be surrendered and a site plan entered into between the applicant and the Township. The required site plan agreement would establish that the fill operation must comply with the Township's Site Alteration By-law, although no fill permit would be required, and the operation would be regulated through the site plan agreement. The applicant made modifications to their site plan application in 2019 which required additional reports and documentation to be filed.
