- Partner with Canadian Tire and Jumpstart to build a fully accessible multi-sport court in 2021.
- Complete numerous pathway and trail improvement projects.

Local businesses and our residents have gone above and beyond to protect our most vulnerable residents and to ensure every one of all abilities can participate in our community with dignity and independence.

An Update from the Township of Uxbridge Accessibility Advisory Committee

It is fair to say that 2020 has been a year of unprecedented change. Our committee has remained committed to working with the Township to support our legislative roles and responsibilities.

In 2020, we have several projects that have been reviewed by the committee. These projects are pending, however, consultation and recommendations have been provided to the municipality:

- Universal Playground Elgin Park, Lions Club initiative
- Elgin Park Accessible Seating and Pathway Paving
- Kennedy Fields Skate Park / Baseball Diamonds
- Winter Sidewalk Clearing
- Uxbridge Historical Centre Accessible Updates with Trillium Grant Funding
- Provision of "Letters of Support" to support grant applications that address accessibility within the Township (Uxbridge Seniors Centre, Uxbridge Youth Centre)
- Nomination and Acknowledgement of Local Builder who demonstrated commitment to accessibility above and beyond the Ontario Building Code.

We remain committed to our core responsibility: advocacy, knowledge of accessibility standards and providing education to the municipality and key stakeholders about accessibility, equity, and inclusion from a broad lens.

We look forward to working with the Township on several new initiatives in 2021. While working collaboratively with our municipal council, the AAC will remain proactive, responsive and committed to ensuring a barrier free Uxbridge.

In 2020, the Township upheld its commitments outlined in the 2020-2025 Multi-Year Accessibility Plan, including:


- ✓ The expansion of digital services resulting in an improved customer experience, including the digitalization of fire permits.
- ✓ Implement a new user-friendly Township website, in compliance with WCAG 2.0 Level AA criteria.
- ✓ Improve support to Township employees in the areas of mental health and wellness through a range of supports and resources.
- ✓ Continue to prioritize accessibility in every element of infrastructure projects at Township owned facility and public spaces through rigorous consultation with the Accessibility Advisory Committee.
- ✓ Digitalize our bids and tenders process to improve the opportunity of doing business with the Township for all suppliers, including those with disabilities.
- ✓ In conjunction with the BIA and Accessibility Advisory Committee, work with local businesses to identify, remove and prevent barriers to accessibility to make the entire Township holistically accessible.
- ✓ Continue to recognize local businesses that show leadership in improving accessibility and promoting inclusion by nominating an award winning local business for the 2020 Region of Durham Accessibility Award (Brandon Bird, CEO, Bernard Cole Corp.)

Township of Uxbridge's 2020 Highlights

New Township Website

In February 2020, the Township launched its new, fully accessible website. The website conforms to the Web Content Accessibility Guidelines (WCAG) Level 2.0 AA criteria. The website allows users with a broad range of disabilities, particularly those with hearing and visual impairments, to navigate with ease.

In partnership with various online platforms, the Township is now able to offer accessible meeting agendas and minutes in a variety of formats, as well as accept online payments and easy-to-submit forms and applications. The website has also allowed the Township to offer a fully digital and accessible procurement platform – improving opportunity of doing business with the Township for all suppliers, including those with disabilities.



The Township of Uxbridge is proud to offer a fully accessible digital platform for our residents, and we are looking forward to expanding what we offer online, including an expanded library of online forms and increased opportunities to make payments online.

Partner with the Uxbridge & District Lions Club to Build a Universal Playground at Elgin Park



The Township of Uxbridge and the Accessibility Advisory Committee have partnered with the Uxbridge & District Lions Club to plan and build a universal playground at Elgin Park.

The Universal Playground is a "first" for the Township, highlighting our dedication to finding new and innovative ways to remove barriers and allow everyone to participate

meaningfully in all aspects of our community.

The Universal Playground will have a rubberized surface with ramps for mobility access, and interactive panels for children of all abilities. The Universal Playground is being designed with the developmental importance of particular playground equipment at top of mind, ensuring that all children, and their caregivers, regardless of ability, can play and participate.

Accessibility for Ontarians with Disabilities Act, 2005 Compliance

The Accessibility for Ontarian with Disabilities Act, 2005 (AODA) became law in 2005. Under the Act, organizations must meet the requirements of the AODA in the areas of information and communications, employment, transportation, design of public spaces and customer service. The summary below highlights the AODA requirements that are now part of the Township of Uxbridge's day-to-day operations.

- ✓ Provide accessible customer service
- ✓ Provide emergency and public safety information in accessible formats
- ✓ Provide employees with accessible and customized emergency information
- ✓ Create accessibility policies and a multi-year plan
- ✓ Buy accessible goods, services or facilities
- ✓ Make new website accessible
- ✓ Train employees on Ontario's accessibility laws
- ✓ Make it easy to provide feedback
- ✓ Make employment practices accessible
- ✓ Make public information accessible, when requested
- ✓ Make new or redeveloped public spaces accessible
- Consult regularly with the Accessibility Advisory Committee on all matters related to accessibility within the Township

Dedication to Continuous Improvement & Celebrating Success

The Township of Uxbridge is committed to improving accessibility beyond legislated requirements. We are continuously working on our internal processes to create better efficiencies, which ultimately benefit residents. Staff who are responsible for posting information attend AODA training sessions. Project charters are being developed for all new operational and capital projects to help identify barriers to accessibility and engage with relevant stakeholders.


Accessibility improvements and changes to accessibility legislation will also be reflected in updates like this.
